STRUCTURE AND MANAGEMENT

The Bellarine Springs Residents Association is an unincorporated not-for-profit organisation. It is managed by a Committee whose members are elected annually by the Association membership.

Operating funds are raised solely from its members, with the majority of the funds raised through sales across the bar. Funds are distributed to groups of residents for the purposes of the residents only. During the year \$518 were returned to interest groups being for a stainless steel food trolley for the kitchen, Mah-Jong sets, incidentals for the Winter solstice and tennis balls. The association also supported residents by subsidising lunches and dinners catered for by private companies, in the range \$10 to \$20 per head.

Each year, the Association must assess its income tax status: the self-assessment for FY 2020-21 is that the Association is not liable to pay income tax for the current financial year, principally on the basis that all monies are raised from members, and spent for the benefit of members only, according to the Rules of Association Section 7.

VICE PRESIDENT'S REPORT

This certainly curtailed the usual full calendar of events and activities that the BSRA and other residents organise on behalf of the village. Nevertheless, we did manage a number of activities in the gaps where restrictions were relaxed, and we could get sufficient numbers into the community centre or other venues. I won't steal Faye Quinn's limelight as she will list out the events we have managed to undertake.

This committee continued the approach of supporting village residents who wished to organise events with funds and other support. I would like to recognise all residents that have taken on a role to get an event up and running whether it be Dim Sims at Happy Hour (Athol, Faye, and Allan), the emerging Cocktail Group (Heather, Sandra and Grahame), the Whisky Appreciation Society (Ross and Tony), the Café Zoo group (Wendy B). The 2021 Christmas Lunch in the Village is also being organised by Heather, Colin and Grahame who have also had a role in the Rock'n'roll events. There have been some lunches organised by Judy Streich when we aren't in lockdown. We also enjoyed a Winter Solstice around the fire thanks to Delia who also helps out residents with IT support and outings.

I would be remiss if I didn't recognise some of the hardworking people who support the village in other ways, firstly the Veggie Garden gang, Maureen, Geoff, Barbara, and Greg. Many wouldn't get their 'three a day' without the products on the veggie table. Also, Steve who can always be relied upon to produce miracles in the Village Shed. Steve also provides plenty of entertainment and prizes as part of the Friday night raffles. Jurgen Streich and other bus drivers who have taken hundreds of residents to shopping and other outings. And finally, let's not forget the bar team and volunteers who keep us lubricated at our Happy Hours!

Other regular groups and events continued when possible and groups saw some growth in membership and achievements. For example, the Cycling group saw some milestones (pun intended) with a few significant distances covered. The motorbike group continued to terrorise the local windy roads and coffee shops. The various card and board game groups have got back to being very active in the Community Centre. Fitness classes have stopped and restarted. The Walking group have found a number of creative ways to keep within the health advice restrictions to give Molly dog her exercise.

Given there is so much that goes on in our Village I'm sure I have missed some events or worthy people in the thanks above. If I have missed you out it is because of my fading faculties rather than you not deserving a mention. Again my thanks to everyone who gets involved!

The BSRA committee worked around the issue of not having an elected President by adopting a very flexible approach to running our meetings and making decisions. Firstly, the responsibility for running the monthly meeting was shared around the team so that everyone had a chance to experience being the meeting Chair. We also made sure we could make prompt decisions even if locked down by setting up an email 'round robin' to approve expenditure or other decisions which would then be ratified at the next committee meeting.

We also continued our approach of working collaboratively with Village Management and I would like to acknowledge the assistance and support we have received from Kent Hodgson, Meagan Park and Michael Morgan. The fact that we finally have a flat bowling green is an example of that cooperation, now for a larger bus! We also appreciate the cooperation from Wendy Prasevic in getting the Welcome Packs to new residents and help with events.

Frank Boase and Robert Burza continue to do a great job around the village keeping the grounds in great shape. As busy as they are there is always time for a friendly wave. The Happy Garden has also gone from strength to strength, and I see a new project kicking off behind the community centre, thanks to Norma as well.

I would also like to pass on my sincere thanks to my fellow committee members, Geoff Turner, Jeff Keane, Alan Clarke, Athol Johnson, John Clark, Faye Quinn, and Helen Downes. They have all worked hard to manage the ups and downs of the last 12 months. They have also adapted well to a different way of working together.

Finally, I'd like to thank the village residents for their support over my last three years on the BSRA committee. It has been a good deal of fun, occasionally a little hard work but very rewarding. I would strongly recommend residents to get involved in Village life, whether it be by taking on a committee role or simply organising or supporting an activity for the rest of the residents. You'll find it as rewarding as I have.

Communication

Minutes of the Committee meetings are available to members via:

- Direct email to those who have indicated that they wish to receive minutes regularly;
- Hardcopy kept in a blue folder in the Library, available for photocopying; and

Members of the Committee have been open to the Association members for comments and suggestions, which can be discussed at the monthly meetings. In addition a series of Listening Posts were held (although interrupted by COVID) in the Community Centre in June. Reports from these Listening Posts were incorporated with other reports presented to the following Committee meetings, and are available as part of the minutes for the months of June and July.

Membership

According to the Rules of Association, the Secretary must keep and maintain a register of members that includes:

- 1) for each current member
 - a) the member's name;
 - b) the address for notice last given by the member;
 - c) the date of becoming a member;
 - d) any other information determined by the Committee; and
- 2) for each former member, the date of ceasing to be a member.

During the year 2020-2021, 28 new residents applied for membership, four members moved out of the Village, and sadly one member passed on, resulting in the Total Membership at the close of the year being 181

As at the close of membership registration on August 11 for the purposes of voting at the AGM, there are 187 members in 120 households, which is a ratio of 1.6 members per household. Incidentally, that ratio has been consistent for the life of the Village.

Representation

The Village Manager was invited to each Committee Meeting to present his Management Report, which included a summary of the monthly Village Budget and expenditure.

In addition, at least two members of the Committee have attended the monthly Management Advisory meetings, with a third attendee from the general residential population. These monthly meetings (required under the Retirement Villages Act 1986) enable both Management and residents to raise and discuss matters of interest to the membership. A good working relationship has been fostered by all parties and will continue in the future.

RECYCLING REPORT

Over the past year we have been able to recycle plastic bottle tops, bread tags, metal ring pulls from cans, and small batteries.

The plastic bottle tops are delivered to Dive Victoria who involve school groups in science and environmental projects. One of the projects is to recycle the tops into moulding powder, which is used to make fobs for key chains and other "nick nacks" which are sold to support school programs. Thanks to Andrew D for delivering the tops.

Wheelchairs and mobility aids are made for kids in developing countries using the money raised from sale of aluminium cans, ring pulls and bread tags. Our collections are forwarded to the appropriate organisations.

The batteries are added to the Bellarine North Rotary Club collection and taken to the North Geelong Resource Recovery Centre.

TREASURER'S REPORT

For year ending 30th June 2021

Bellarine Springs Residents Association (BSRA) is an unincorporated, not-for-profit body and as such all monies raised must be spent on benefiting the residents of the village. The Association is not permitted to donate any member funds to any other groups or charities. (The Association may use its bank account to deposit then forward funds raised by members through fun-raising events specifically for Charities)

The uncertain COVID restrictions during the year resulted in decreases in income to \$15241.70 and expenditure to \$13381.43, with a net income of \$1860.27. Major donation throughout the year was \$800 from the community vegetable garden group.

The NAB general and debit accounts were closed and the proceeds transferred to a Bendigo general account with 3 signatures, any 2 required to authorise payments, in addition a debit account was opened with \$1500 for Bar purchases.

Throughout the year \$706 was spent on morning teas, \$434 to purchase equipment for interest groups and \$2400 subsidising social events.
