Our purpose

The purpose of the Association is to serve the interests of its Membership, the residents of Bellarine Springs. It will:

- 1. Encourage, support and promote the wellbeing of Members, welcome them to Village life and support them in times of difficulty;
- 2. Represent and advocate for Members in matters which the Association deems appropriate; including negotiations with Village Management and Village Owners on matters of interest to the general Membership;
- 3. Establish and support an organisational structure that facilitates the development of activities and events which enhance the enjoyment of Village life; and
- 4. Review and where necessary modify the role and functions of the Association and its organisational structures to meet changing circumstances.

Our History

In late 2016 a small group of residents at Bellarine Springs Village discussed the possibility of forming a resident's association. In January 2017 a meeting of all residents, then numbering 28, was called to determine support for the idea. All 25 residents present at the meeting supported the idea, and a Working Group (P Lewis, G Turner, J Jones, S Evans, V Bishop; M Walker) was elected to draft a Constitution. The Working Group considered that the best option for the Association structure was as an unincorporated body, given its small membership and lack of significant assets.

A meeting of all 37 residents on 22 March 2017 voted unanimously to adopt the proposed Constitution and elected the founding Committee of P Lewis (President/Chair), S Evans (VP), J Jones (Secretary), B Chalmers (Treasurer), C McKenzie and M Walker (Ordinary Members). The first Annual General Meeting for the Association was held in September 2018.

Subsequent Annual General Meetings held in September 2019 and September 2020.

Bellarine Springs Residents Association is an unincorporated non-profit organisation. It is managed by a Committee whose members are elected annually by the Association membership.

Madam Presidents Report - September 2020

I am pleased to present my President's report to the 2020 Annual General Meeting covering our achievements in 2019/2020. During this period our village population has grown to 170 current residents. It is especially wonderful that all have joined as members of the Bellarine Springs Residents Association (BSRA)

September 2019 to February 2020 we enjoyed wonderful village activities: Spanish paella lunch, our first Open Garden Day, Christmas lights competition, end of year lunch at Terindah winery, zucchini bake off to test resident's culinary skills, combined with an Australia Day BBQ with proceeds raised to support the bushfire appeal.

Introduction of Theatre Group with a Melbourne outing to see the show Chicago.

Our activities list expanded to include tennis, water colour painting/ art support group, the game Rummikub was introduced, bike riding group, comedy movie group, crime club, gluten-free lunch group and motorbike riders group.

At the start of 2020 we worked with management to promote IT training program encouraging residents learn or up-skill their IT skills. It was terrific so many took up the opportunity to learn how to more fully use mobile phones and iPads and improve their ability to communicate with family, shop online and maintain their independence by reading news online. This proved especially valuable when the Covid isolation rules came into effect.

From January the village started operating our own TV channels BSTV101 and BSTV102. With assistance of the residents IT working party and our Manager Kent we were able to ensure all interested residents were connected. What a timely introduction given the world pandemic impact! Via TV link we are quickly able to keep residents informed of latest changes, display photos of different things happening in the village and even have a daily exercise program to help us stay fit during lockdown.

Due to social distancing limitations caused by COVID-19 your Committee was also challenged by technology. We were unable to physically meet for a number of months, so we too had to learn to more effectively communicate by emails and participate in Zoom meeting format.

To explore Village issues in greater detail, the Committee formed a number of working groups namely, the Repairs and Maintenance Working group, Happy Garden working group, Bowling Green working group, Village Bus usage working group. Unfortunately due to Covid restrictions, these have been suspended till we return to normal life.

The Committee and management developed a very collaborative relationship. We streamlined our monthly meetings to reduce 'red tape' where possible and put action into place in a more timely manner. I gratefully acknowledge the ongoing support of our management team. Kent Hodgson, Meagan Park, Michael Morgan.

Thank you to Wendy Prascevic our sales person who actively assists the committee help new residents settle in via our Buddy scheme (now known as the Village Welcome program).

Also many thanks Frank Boase and Robert Burza, our gardeners, who have been wonderful working with the Happy Garden working party and from time to time assisting the community vegetable garden surrounds and paths etc.

I extend my sincere thanks and appreciation to the Committee members, Andrew Downard, Sandra Adams, Maggie Smith, Anne Cowden, Alan Nettley, Graham Knight and Alan Clarke. All have been very supportive and readily adapted to the many challenges this past 12 months has given us.

I particularly thank all of you residents. It has been my privilege to be your President. I enjoyed getting to meet you and to be challenged by the many issues that arise in a community. Thank you all for your support, kind words and especially your willingness to get involved when I asked for assistance.

I strongly encourage all residents to become actively involved in our Village. We all live in a wonderful caring Community of independent people. Your individual contributions, however small, means a stronger more vibrant community life we can all continue to enjoy, no matter what challenges life presents us.

Secretary's Report

Compliance

Although unincorporated the Association Committee conducted its affairs in a manner consistent with the requirements of the Board of an incorporated association and in accordance with its own Rules. The Committee is required to hold not less than four Ordinary meetings per year. Ordinary monthly meetings were held in July and August 2019, by the former Committee, and 7 Ordinary meetings, 1 Extra Special meeting, 2 Zoom meetings, and 1 email meeting have been held by the current Committee.

Communications

Minutes of Committee meetings are available to members in four ways. Members may receive them by e-mail, mailbox, they may read the hard copy in the Library, or they may access them on the copy held on the computers in the Library.

A Community Meeting was held in September 2019 which Management also attended to discuss the proposed expansion to stage 10 and the impact to the village currently. The Repairs and Maintenance Guidelines was also discussed and a working party has been established to explore in detail discussions with management for an outcome.

Madam President wrote a monthly memo – paper copy provided to each household to keep residents updated.

Representation

Three members of the Committee have made themselves available as a Management Advisory group to meet with Management on a monthly basis. This enables both parties to raise and discuss matters of interest to the membership. A good working relationship exists and has led to resolution of a number of issues, and as is still ongoing with relation to the Repairs and Maintenance Guidelines. This Advisory Group has recently been exclusively concentrating on finance management matters and the effect on the village.

To aid in communications between Committee and Management the Manager, Kent Hodgson has been invited since March to join at the end of our monthly meetings to discuss Q&A of Village matters raised. This ensures quicker answers and actions can be taken.

Support Village Life

Your Committee has continued with the Buddy system which assists new residents settling in. The scheme has been adjusted over the past two years to best meet new resident needs. A detailed Welcome Pack has now been developed. It was felt however that the term "Buddy" is a misnomer and some new residents did not respond well to the name. Following feedback from new residents and buddies it has been decided to rename it as "Village Welcome Program".

Individual members have been encouraged by the Committee to organise interest groups or special events and funding has been provided to support this. During 2020 several planned events were unfortunately cancelled due to the Covid-19 restrictions. Responsibility for the management of the Bar operations still rests with the Committee, however bar operations have closed during Covid-19.

Treasurers Report:

Bellarine Springs Residents Association (BSRA) is an unincorporated, not-for-profit body and as such all monies raised must be spent on benefitting the residents of the village. The Association is not permitted to donate any member funds to any other groups or charities. (The Association may use its bank account to deposit then forward funds raised by members through fund-raising events specifically for Charities.)

We began the year with \$4377.87 in the bank and \$565.90 in cash, and on the 30 Jun 2020, we finished the financial year with \$6994.69 plus stock from the Bar \$1861.00

Social event spending included the Mid-Year Function at the Clifton Springs Golf Club and the End of Year Function at Terindah Winery. On site activities were organised by the Social Club (now defunct) including Spanish Paella Day, French Bastille Day and BBQs.

Unfortunately, in March 2020, the Covid19 virus arrived in Australia. This meant the end of social events until the Government allows them. Money has been allocated for future events, including the End of Year Function which will be subsidized.
