Our purpose

The purpose of the Association is to serve the interests of its Membership, the Residents of Bellarine Springs. It will:

- 1. Encourage, support and promote the wellbeing of Members, welcome them to Village life and support them in times of difficulty;
- 2. Represent and advocate for Members in matters which the Association deems appropriate; including negotiations with Village Management and Village Owners on matters of interest to the general Membership;
- 3. Establish and support an organisational structure that facilitates the development of activities and events which enhance the enjoyment of Village life; and
- 4. Review and where necessary modify the role and functions of the Association and its organisational structures to meet changing circumstances.

Our History

In late 2016 a small group of residents at Bellarine Springs Village discussed the possibility of forming a resident's association. In January 2017 a meeting of all residents, then numbering 28, was called to determine support for the idea. All 25 residents present at the meeting supported the idea, and a Working Group (P Lewis, G Turner, J Jones, S Evans, V Bishop; M Walker) was elected to draft a Constitution. The Working Group considered that the best option for the Association structure was as an unincorporated body, given its small membership and lack of significant assets.

A meeting of all 37 residents on 22 March 2017 voted unanimously to adopt the proposed Constitution and elected the founding Committee of P Lewis (President/Chair), S Evans (VP), J Jones (Secretary), B Chalmers (Treasurer), C McKenzie and M Walker (Ordinary Members). The first Annual General Meeting for the Association was held in September 2018.

Structure & Management

Bellarine Springs Residents Association is an unincorporated non-profit organisation. It is managed by a Committee whose members are elected annually by the Association membership.

President's Report

I am pleased to present my President's report to the 2019 Annual General Meeting covering our achievements in 2018/19. During this period our Village population has grown from 98 to 139 residents who now call Bellarine Springs home.

We are an Independent Living Community and the committee has been mindful of encouraging and supporting this concept by:

- providing a wide range of activities in the Community Centre. We now have a list of 26 groups in place.
- promoting events including fashion shows, makeup, speakers about travel, fire evacuation and updating batteries, PTV guest speaker on local transport options
- hosting Lara Village residents for a bowls and snooker event.
- as many residents expressed interest in being active, purchasing equipment to promote these healthy activities: exercise class, croquet, bowls, darts and table tennis.
- establishing a BSRA library area with all Minutes, policies (including insurance), local tradespeople register.

- enhancing our community centre atmosphere by buying large Christmas tree and decorations, an audio speaker system and a lightweight stick vac to assist with our cleanups,
- promoting "Reduce, reuse and recycle" concepts to inform and suggest ways residents can become involved to reduce our carbon footprint.
- introducing an Events Group (run by Heather Trahar, Graeme Knight and Colin McKenzie) to organise large functions throughout the year (including Chinese New Year, St Patrick's Day, Bastille Day, Christmas in July). Residents have embraced the spirit of these events as evidenced by the photo on this report cover.
- advocating on behalf of residents rate notice evaluations and achieving a reduction in rates.
- encouraging and promoting the submission and petition undertaken by residents to have Council build a footpath along Central Road.

I gratefully acknowledge the support received from management. Vicki Carbines and Mark Graham, who have left us and especially our current Manager Kent Hodgson and Meagan Park.

Through our dealings with them on Village issues, it is pleasing to have most of the defect works now rectified for stages 1&2 and a streamlined reporting system in place; bowling green audit completed (with maintenance issues investigated), speed limit and road signage now organised, continuous review and changes to Village bus routes; our gardens developing well under Franks good management with an apprentice to join him shortly; and working collaboratively with management and Sales, our Buddy scheme is assisting all new residents have a smooth transition to Village life.

I especially thank my committee -Andrew Downard, Judith Jones, Maggie Smith, Anne Cowden, Alan Nettley and Graham Knight for their willingness to explore new ways of doing things, collaborative attitude and mutual support.

I specifically want to recognise and thank the many "quiet achievers" who without any fanfare, step in and continuously do daily tasks to keep our Village running smoothly. I have listed them on a separate attachment. Your efforts are much appreciated.

It has been my honour to be President of the BSRA and I appreciate the varied opportunities given me in this role, from negotiating, meeting local Councillors to Federal MPs and especially the chance to get to know and work closely with all residents.

We live in a beautiful area on the Bellarine and we have a very friendly, caring community. I look forward to seeing resident participation continuing to blossom. I specifically encourage new residents to become active in our Village and share their rich life experiences by introducing new activities for us all to explore.

Secretary's Report

Compliance

Although unincorporated the Association Committee conducted its affairs in a manner consistent with the requirements of the Board of an incorporated association and in accordance with its own Rules.

The Committee is required to hold not less than four Ordinary meetings per year. Ordinary monthly meetings were held in July and August 2018, by the former Committee, and 10 Ordinary meetings have been held by the current Committee. No Committee member was absent for more than 2 of these meetings.

Communication

Minutes of Committee meetings are available to members in three ways. Members may receive them by e-mail, they may read the hard copy held in the Library or they may access them on the Library computers. Six members of the Committee hosted a "Q&A' session with members in March, which the Manager also attended. The 25 resident members who attended were able to raise issues which were either addressed immediately or followed-up later. The Secretary writes a column on Association business in the monthly Village Newsletter, and the President writes a mid-monthly Memo reporting on events, activities and matters of interest to members. Members are invited to contact the Committee through e-mail or in writing via the BSRA box in the Library.

Representation

Two or three members of the Committee made themselves available to meet with Management on a monthly basis. This enabled both parties to raise and discuss matters of interest to the membership. A good working relationship exists and has led to the resolution of a number of issues.

Support Village Life

Your Committee has continued with the Buddy system which assists new residents in settling in. Individual members have been encouraged by the Committee to organise interest groups or special events and funding has been provided to support this. Responsibility for the management of the Bar operations now rests with the Committee following changes during the year.

Treasurer's Report

Bellarine Springs Residents Association (BSRA) is an unincorporated, not-for-profit body and as such all monies raised must be spent on benefitting the residents of the village. The Association is not permitted to donate any member funds to any other groups or charities. (The Association may use its bank account to deposit then forward funds raised by members through fund-raising events specifically for charities.)

We began the year with \$4377.87 in the bank and \$565.90 in cash, and on the 30 Jun 2019, we finished the financial year with \$6785.31 banked and \$443.70 cash on hand. We have allocated \$1600 being \$20 pp to subsidise the Mid-year function and \$4050, \$35 pp, to subsidise the End of Year Function.

The figures in the Profit and Loss Statement include funds transferred from The Bar 2018 and Social Club when BSRA took over the management of these.

Your Committee supported various interest groups with funds for sporting equipment (½ cost of the indoor bowling equipment, rowing machine, table tennis table, croquet, dart board and minor equipment for the fitness classes), a Mah-jong set, craft materials and items for the community garden group.

Social event spending included the music machine, funding the Christmas function and social days.

Petty Cash spending was for low cost items such as stationery, kitchen items, gym equipment, support for the Nostalgia Theatre and morning teas.

The BSRA Committee is always open to your suggestions on how to spend YOUR money. Application for Funds forms are in the Community Centre.

I'd like to thank everyone for your support while I have been treasurer. I hope you are happy with the way the money has been spent over the year. Detailed Monthly Financial Statements are in the BSRA Minutes file in the library. Please feel free to ask if you are concerned about how the money is being spent.
